

# Alex's Feline Training and Behavior Consulting, LLC Services Agreement

This Service Agreement (the "Agreement") dated this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_ is between \_\_\_\_\_, herein referred to as "Client" and Alex's Feline Training and Behavior Consulting, LLC herein referred to as "Trainer".

Trainer agrees to provide training services to Client, while Client agrees to provide remuneration for training services and adhere to the training guidelines as per the terms and conditions set out in this Agreement.

## Agreement Term

This Agreement will begin on \_\_\_\_\_ and will remain in full force and effect until the completion of the Services. This Agreement may be extended by mutual written agreement of the parties.

## Services

Trainer agrees to provide behavior modification information and training for \_\_\_\_\_ to Client and Client's cat(s) \_\_\_\_\_, beginning with a phone consultation, followed by weekly in-home training sessions until the \_\_\_\_\_ problem is resolved to best of the Trainer's ability. The Client agrees to follow all Trainer instructions and recommendations to solve the specified problem behavior, which may include veterinary health checks, product purchases, and daily behavior modification exercises and/or practices. Trainer makes no guarantees of \_\_\_\_\_ behavior or performance as a result of the training sessions and consultations.

## Payment

Client agrees to the following rates for services provided. All fees are nonrefundable.

- a. Initial Behavior Consulting Session - \$225 for in-home session, which will not be more than two hours in length  
\$175 for Virtual session, which will not be more than two hours in length
- b. Single Behavior Modification Follow-up Session- \$100 for in-home session, which will not be more than one hour in length  
\$75 for Virtual session, which will not be more than one hour in length
- c. Behavior Modification 4 Follow-up Session Package - \$90 per in-home session, which will not be more than one hour in length if client purchases four sessions at one time  
\$67.5 per Virtual session, which will not be more than one hour in length if client purchases four sessions at one time
- d. In-Home Training Sessions:
  - Single ½ hour Training Session - \$60 per in-home session, which will not exceed more than 30 minutes  
- \$50 per Skype\Virtual session, which will not exceed more than 30 minutes
  - 4 Training Session Bundle - \$57 per in-home session, which will not be more than 30 minutes in length if client purchases four sessions at one time  
- \$47.50 per Skype\Virtual session, which will not be more than 30 minutes in length if client purchases four sessions at one time
  - 8 Training Session Bundle - \$54 per session, which will not be more than 30 minutes in length if client purchases eight sessions at one time.  
- \$45 per Skype\Virtual session, which will not be more than 30 minutes in length if client purchases four sessions at one time.
- e. In Home Cat Care:
  - Sitting - \$36 per visit if within 10 miles of 5510 Concord Downs Drive, \$41 per visit if between 10 – 15 miles of 5510 Concord Downs Drive, which will not be more than 45 minutes; \$15 for each additional 30 minutes after first 45 minutes.
  - Cat Walks (trained cats only) - \$30 for a single walk, which will not be more than 20 minutes in length
    - Package of 4 walks: \$27 per walk, which will not be more than 30 minutes in length if client purchases 4 sessions at one time
    - Package of 9 walks: \$25.5 per walk, which will not be more than 30 minutes in length if client purchases 9 sessions at one time

Play Sessions - \$20 for a single session, which will not be more than 20 minutes in length

- Package of 4 play sessions: \$18 per session, which will not be more than 30 minutes in length if client purchases 4 sessions at one time

f. Pet Taxi Service:

One Way Trip - \$19 if within a 5 mile radius (\* if over 5 mile radius, add \$0.75 per mile)

Pick up AND Drop off - \$35 if within a 5 mile radius (\* if over 5 mile radius, add \$0.75 per mile)

g. Additional services added to any above service:

Video - \$2 per cat, brief video of cat playing, walking, or training to be taken on Trainer's phone and sent to Client

Nail Trims - \$8 per cat, front paws only

Nail Cap Placements - \$5 per cat, front paws only

"Mini Train" Session - \$30 per each booking

Client agree to purchase as indicated above and initialed for the duration of this agreement.

If Client fails to give at least 48-hour cancellation notice, or fails to appear for the scheduled appointment, the training fees will still be owed.

### Liability Limitations

If \_\_\_\_\_ causes property damage, or bites or injures any animal or person, during or after training sessions, Trainer is not liable for any resulting losses and damages suffered or incurred, or any resulting claims, demands, lawsuits, costs or expenses, including attorney fees. If \_\_\_\_\_ is injured during or after training session, Trainer is not liable any resulting injuries, losses, damages, costs or expenses.

### Termination of Agreement

With reasonable cause, either Trainer or Client may terminate this Agreement, effective immediately upon the receipt of written notice. Reasonable cause includes:

- a. Material violation of any terms within this Agreement
- b. Any act exposing the other party to liability to others for personal injury or property damage
- c. Financial distress, such as loss of income or bankruptcy

### Miscellaneous

This Agreement contains the entire agreement and understanding by and between Trainer and Client and no representations, promises, agreements, or understandings, written or oral, not herein contained shall be of any force or effect.

This Agreement may be amended with the prior written agreement by both Trainer and Client.

This Agreement and the performance under this Agreement and all suits and special proceedings under this Agreement, be construed in accordance with and governed by the laws of the State of Georgia.
